## HOW DO I ACCESS MY PHYSICIAN FORM?

- Log in to [empowerlinc.com](https://empowerlinc.com) or the MyWellPortal Mobile App with your personal username and password. New users select **Register for a new account** and enter the company code 'pace' to create a profile.
- Scroll down the homepage to the **Biometric Screenings** tile and select **Learn More**.
- Under the **Schedule Your Screening** section, select **Register**.
- To access your required physician screening form, click **I Agree** to the health screening consent, e-sign your name and click **Continue**. You will have the opportunity to download the form and an email will be sent with the form as well. **Please print and bring the form to your appointment.**
- After your screening, you will receive an email within 10 business days notifying you that your results are available. Once received, please log into [empowerlinc.com](https://empowerlinc.com) and select the Biometric Screenings tile to review your results.

## Premium Surcharge Overview

Associates hired on or before November 30, 2023 and enrolled in a Pace BCBS of Arkansas medical plan may be assessed a monthly surcharge of \$130 per month for failure to participate in the Pace Wellness program.

**Step 1:** Schedule your annual physical with an in-network primary care doctor. Already had a physical? If it was April 1, 2023 or later, take your physician form to your doctor for completion of the required information.

**Step 2:** Register & download your physician form through your Marquee Health portal by **March 24, 2024.**

# 2023 - 2024 WELLNESS PROGRAM

As part of Pace Industries' continual efforts to promote wellness, we have launched a new Associate wellness program for the 2023 – 2024 plan year. The program focuses on scheduling and completing your annual wellness exam to help maintain and improve your health. The Pace medical plan covers your wellness visits (Preventative Care) at 100% without charging a copayment, coinsurance or deductible, if services are received by an in-network provider (restrictions apply). Associates who fully participate in the program will avoid a monthly surcharge on their medical premium beginning July 1, 2024.

## NEW HIRE PARTICIPATION

- Associates hired on or after December 1, 2023, and enrolled in a Pace BCBS of Arkansas medical plan will begin participation in the Pace Wellness program during the 2024/2025 benefit plan year.
